SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found HERE.

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. ARP-ESSER Application – Part 1: The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. Under the Poughkeepsie City School District's continuous improvement model, the superintendent of schools provides quarterly updates to the Board of Education and community on the status of all major projects, district goals, and performance objectives. The Poughkeepsie City School district will expand its continuous improvement model of monitoring and adjusting to meet project goals to also include the programming under ARP. There will also be many entry points for students to receive the services, programming, and supports described in the district's plan which include: referral, academic monitoring, social emotional monitoring, and student interest.

In comparison with surrounding districts, the Poughkeepsie CSD population has been disproportionately impacted by the COVID-19 pandemic. The Poughkeepsie CSD is 80% Low Income, 19% SWD, 12% ENL, and at least 75% students of color. Our main targets are

Students with Disabilities (SWD): whose disability significantly impedes their success in school are being provided supports with ARP funds by providing extended learning time programs and Saturday programs. We are hiring full-time personnel (Social Workers, Counselors, and Parent Liaisons) to address the social emotional, wellness needs, as well as at risk attendance issues and provide positive youth development.

ELL students: With ARP funds the District providing an ENL extended learning program and hiring Parent Liaisons to assist with collaborating agencies to provide additional services to our ELLS.

Students experiencing homelessness, foster care, or are migratory: With ARP funds the District is providing programming after school and on Saturdays by providing greater opportunities for positive youth development and social emotional supports for students. In addition, we are collaborating with multiple vendors to provide trainings and/or supports such as mental health services and trauma informed training. The District is hiring Parent Liaisons that will collaborate with local agencies to provide supports such has housing, meals, personal needs, as well as mediating with the migrant workers program.
