POSITION:

The Superintendent of Schools, Dr. Eric Jay Rosser, is interested in receiving applications from qualified candidates for the position of:

(4) CURRICULUM WRITERS FOR LIVING ENVIRONMENT:

- 1 Special Education Teacher (5 days)
- 1 ENL teacher (1 day)
- 2 Living Environment teachers (5 days)

QUALIFICATIONS:

NYS Teacher certification

Candidates must complete a resumé and a letter of interest for consideration of appointment

DUTIES:

The Poughkeepsie City School District (PCSD) is committed to providing students and parents with pathways to opportunity that will lead to achievement and success. Through student-centered effective and transformational leadership, school and community engagement, and an unrelenting pursuit to achieve greater school outcomes for children, the Poughkeepsie City Schools is focused on developing and growing greater access, equity, opportunity, and quality across PCSD.

As reflected in the approved curriculum writing proposal, curriculum writers will redistribute content throughout two rounds of instruction, replacing overview statements, Standards, and Essential questions to align with NGSS. On days 3 and 4, writers will include the adjustment of current strategies and Key Ideas to fit the new sequence while revamping and separating them into plant vs. animal strategies to be placed appropriately. Any additional time will be spent developing new lesson materials to be added to fill in any "holes" created by the topic separation. The final day will be a collaboration between the 3 disciplines to discuss any modifications that should be considered due to specialized learning needs of the students in their specialities.

Curriculum writers will submit their work half way through the process (after 2 days of work) for feedback and written approval prior to completing the project.

APPOINTMENT:

Appointment will be made by the Board of Education upon the recommendation of the Superintendent following assessment of training, experience, certifications, credentials and evaluation of service. Personal interviews shall be conducted where appropriate.

EFFECTIVE DATE: All curriculum writers are expected to submit their curricula for feedback and approval no later than Aug 1, 2022 and all work to be completed no later than Sep 1, 2022.

SALARY: As per PPSTA contract

- 1 special education teacher not to exceed 30 hours or \$2,100 each
- 2 living environment teachers not to exceed 30 hours or \$2,100 each
- 1 ENL teacher not to exceed 6 hours or \$420
