PBIS establishes a social culture and the behavior supports needed to improve social, emotional, behavioral, and academic outcomes for all students.

PCSD is seeking PBIS team members to help create a positive school climate where students can learn and grow including safety, respect, engagement in learning, collaboration, and a shared vision.

All PBIS team members will attend PBIS meetings at least monthly (as organized by the PBIS Coordinator in collaboration with building administration).

All PBIS team members will work in collaboration with the PBIS Coordinators to successfully:

- Support the PBIS Coordinator in creating the Tiered Fidelity Inventory which assesses the core features of PBIS in each of the three tiers
- Track and monitor the implementation of PBIS interventions and school-wide programs to determine the effectiveness of the initiative
- Utilize data to guide interventions and instruction
- Progress monitor data collected to drive decision-making
- Participate in professional development for PBIS implementation

APPOINTMENT:

Appointment will be made by the Board of Education upon the recommendation of the Superintendent following assessment of training, experience, certifications, credentials and evaluation of service. Personal interviews shall be conducted where appropriate.
