

**NOTICE OF ANNUAL DISTRICT MEETING AND ELECTION, BUDGET  
HEARING & RELATED MATTERS  
POUGHKEEPSIE CITY SCHOOL DISTRICT**

**NOTICE IS HEREBY GIVEN** that, pursuant to a resolution of the Board of Education of the Poughkeepsie City School District, Dutchess County, New York, adopted March \_\_, 2024, the annual Public Hearing on the Budget at the Board Room of the Administration Building, 18 S. Perry Street, Poughkeepsie, New York, will be held on May 8, 2024 at 6:30 p.m., for the purpose of presenting the 2024-2025 School Year Budget.

**NOTICE IS FURTHER GIVEN** that a detailed written statement setting forth the amount of money which will be required for School District purposes during the 2024-2025 School Year and specifying the several purposes and the amount for each (the Budget), as prepared by the Board of Education, including the Tax Exemption Report and other required attachments, may be obtained by any District resident at the Public Hearing and at each polling place on the day of the Budget vote, and also may be obtained during the fourteen (14) days immediately preceding the Annual District Meeting and Election, commencing May 8, 2024, except Saturday, Sunday or holidays during regular school hours, 8:30 A.M. to 4:00 P.M., at each of the District's schoolhouses, and at the Administration Building, as well as at each public and free association library in the District and on the District's website.

**NOTICE IS FURTHER GIVEN** that the Annual District Meeting and Election will be held on Tuesday, May 21, 2024, between the hours of 9:00 A.M. and 9:00 P.M., prevailing time, when the polls will be open for the purpose of voting by voting machine, to:

- A. Elect two (2) members of the Board of Education, for a three-year term (through June 30, 2027)
- B. Vote upon the appropriation of the necessary funds to meet the estimated expenditures for School District purposes for the 2024-25 School Year (the Budget); and
- C. Transact such other business as is authorized by law.

**NOTICE IS FURTHER GIVEN** that two members of the Board of Education will be elected due to the expiration of the terms of Dr. Felicia Watson and Fatimah Martinez Santiago. The candidates receiving the highest number of votes will each be elected to an at large full three-year term from July 1, 2024 through June 30, 2027. Pursuant to the provisions of the Education Law, candidates for the at large office of Member of the Board of Education shall be nominated by petition. A separate petition shall be required to nominate each candidate. Each petition shall be signed by at least 100 qualified voters of the District, and shall state the name and residence of the candidate and each signer. Each petition shall be filed with the Clerk of the District between the hours of 9:00 a.m. and 5:00 p.m. E.D.S.T., but no later than 5:00 p.m. on Wednesday, May 1, 2024. Forms of petition may be obtained from the Clerk of the District on weekdays when school is in session, during regular business hours, 8:30 A.M. to 4:00 P.M.

**NOTICE IS FURTHER GIVEN** that the purposes of voting, the School District has been divided into five (5) election districts and that an accurate description of the boundaries of these school election districts is on file and may be inspected at the Office of the Clerk on weekdays when school is in session, during regular work hours, 8:30 A.M. to 4:00 P.M., at the Administration Building, 18. S. Perry Street, Poughkeepsie, New York.

**NOTICE IS FURTHER GIVEN** that the 2024 Annual District Meeting and Election will be held at the following polling places in the School Election Districts hereinafter set forth:

**NOTICE IS FURTHER GIVEN** that the Board of Education of the Poughkeepsie City School District, Dutchess County, New York, has fixed Saturday, May 4, 2024, as the date on which the Board of Registration of said School District will meet at the Administration Building, 18 S. Perry Street, Poughkeepsie, New York, between the hours of 11:00 A.M. and 4:00 P.M., prevailing time, for the purpose of preparing the register of the School District for each election district for the Annual District Meeting and Election, to be held on Tuesday, May 21, 2024, at which time any person shall be entitled to have his/her name placed upon such register if known or proven to the satisfaction of the registrars to be then or thereafter entitled to vote. A qualified voter whose registration to vote in other than school elections is current with the Dutchess County Board of Elections, pursuant to Article 5 of the Election Law, shall be qualified to vote without further registering with the School District's Board of Registration, as well as all qualified voters who shall have previously registered for any Annual or Special District Meeting or Election and who shall have voted to any Annual or Special District Meeting or Election held or conducted at any time during the 2020, 2021, 2022 or 2023 calendar years.

**NOTICE IS FURTHER GIVEN** that the register of voters so prepared shall be filed in the Office of the District Clerk, Administration Building, 18 S. Perry Street, Poughkeepsie, NY, and shall be open for inspection by any qualified voter of the District between the hours of 8:30 a.m. and 4:00 p.m., prevailing time, during the fourteen (14) days prior to the Annual District Meeting and Election. Said register will be open for inspection in each of the polling places during the Annual District Meeting and Election.

**NOTICE IS FURTHER GIVEN** that pursuant to Section 2018-e of the Education Law, applications for early mail ballots may be obtained at the Office of the District Clerk of the School District, during all days in which the School District is in session. Completed applications must be received by the District Clerk no earlier than April 22, 2024 and by May 14, 2024, if early mail ballot is to be mailed to voter. If the early mail ballot is to be delivered personally to the voter at the Office of the District Clerk the completed application must be received by the District Clerk no later than May 20, 2024. No early mail voter's ballot will be canvassed unless it has been received in the Office of the District Clerk during office hours on and after May 15, 2024 until May 20, 2024, except on Sundays, by prearranged appointment, and such list will also be posted

at the polling place or places at the election of members of the board of education. A challenge to an early voting ballot may not be made on the basis that the voter should have applied for an absentee ballot.

**NOTICE IS FURTHER GIVEN** that applications for absentee ballots for the Annual District Meeting and Election may be obtained at the Office of the District Clerk, Administration Building, 18 S. Perry Street, Poughkeepsie, NY. The completed application must be received by the Clerk at least seven (7) days prior to the election if the ballot is to be mailed to the voter or the day before the election, if the ballot is to be delivered personally to the voter. A list of all persons to whom absentee ballots shall have been issued will be available in the Office of the Clerk during regular office hours until the day of the Annual District Meeting and Election. Any qualified voter may file a written challenge of the qualifications of a voter whose name appears on such list, stating the reason for the challenge.

**NOTICE IS FURTHER GIVEN** that military voters who are not currently registered may apply to register as qualified voters of the school district. Military voters may request an application to register as a qualified voter from the District Clerk. Military voter registration application forms must be received in the Office of the District Clerk no later than 5:00 p.m. on May 7, 2024. In order for a military voter to be issued a military ballot, the school district must have received in the office of the school district clerk a valid ballot application no later than 5:00 pm on May 7, 2024. A military voter may designate a preference to receive a military voter registration, military ballot application or military ballot by mail, facsimile transmission or electronic mail in their request for such registration, ballot application, or ballot. Such designation shall remain in effect until revoked or changed by the military voter. Ballots for military voters shall be mailed, or otherwise distributed, no later than May 8, 2024.
